SKI THE NORTHWEST CHALLENGE

You can participate in this unique Northwest Council challenge, to ski or snowboard a minimum of 7 ski areas anywhere in Oregon or Washington, our Industry Members, and ski areas hosting FWSA ski trips. At the end of the season, mail in your **lift tickets** or **credit card receipts** or **photocopy of a current season's pass** showing proof of purchase of lift tickets. Entries and proof of qualification must be received by the Council no later than June 15. The drawing will take place in the fall of the year of entry. You must be 18 years old or older to enter.

The names of all who meet the minimum of 7 resorts visited will be posted on our website, ranked by the number of total resorts. Everyone who completes this challenge will qualify for the Council's year-end drawing for prizes – equipment, services, and lift tickets for the following season.
